USER TERMS OF SERVICE

1. INTRODUCTION

- Welcome to Academic Queries! Your use of our services, including the services we make available through this website (the "Site") and any materials, software or services offered by us in connection with this Site (the "Services") is governed by these terms of service (the "Terms" or "User Terms of Service"), so please carefully read them before using the Services. For the purposes of these Terms, "we," "our," "us," "Academic Queries" and the "Company" refer to Wix Site, the providers and operators of the Services.
- In order to use the Services, you must first agree to these Terms. If you are registering for or using the Services on behalf of an organization or individual, you are agreeing to these Terms for that organization or individual and promising that you have the authority to bind that organization or individual to these Terms. In that case, "you" and "your" will also refer to that organization or individual, wherever possible.
- You must be over 13 years of age to use the Services, and children under the age of 13 / cannot use or register for the Services. If you are over 13 years of age but are not yet of legal age to form a binding contract (in many jurisdictions, this age is 18), then you must get your parent or guardian to read these Terms and agree to them for you before you use the Services. Once the Lesson Services are completed, the Lesson Credits held for those Lesson Services will be considered expended, and additional Lesson Credits will be needed to purchase further Lesson Services. If a Student does not have enough Lesson Credits available at the time of signing up for a Tutor's Lesson Services, he or she will be automatically transferred to a web page where Lesson Credits can be purchased.
- If a Tutor does not accept a Student's request for Lesson Services, or otherwise fails or is unable to provide the Lesson Services, the held Lesson Credits will be credited back into the Student's account. Failure on the part of a Student to claim Lesson Services that he or she has signed up for will result in the forfeiture of held Lesson Credits.
- Students will receive an email summary within a commercially reasonable time after the Lesson Services session is completed. If for some reason there is a discrepancy concerning Lesson Services charges, please contact us at helponassignment7@gmail.com. Academic Queries may require you to submit additional information in order to make determination regarding your balance. All decisions regarding your balance will be final and at Academic Queries sole discretion. Notwithstanding the foregoing, Academic Queries is not responsible if your Account is accessed or used by a third party without your permission.
